

DEPARTMENT OF JUSTICE AND CONSTITUTIONAL DEVELOPMENT**NO. 5718****20 December 2024****MAGISTRATES' COURTS ACT, 1944 (ACT NO. 32 OF 1944) CREATION OF MAGISTERIAL DISTRICTS AND ESTABLISHMENT OF DISTRICT COURTS IN RESPECT OF THE LIMPOPO PROVINCE**

1. I, Thembi Simelane, Minister of Justice and Constitutional Development, acting under section 2(1)(a), (f), (h), (j), (k), and (l) of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944) (the Act), read with item 16(6) of Schedule 6 to the Constitution of the Republic of South Africa, 1996, hereby, in respect of the Limpopo Province and with effect from 3 February 2025---
 - (a) withdraw all previous Government Notices creating and establishing magisterial districts, sub-districts, places for the holding of court and periodical courts and describing local limits relating to such courts in the Limpopo Province, published before the date on which this Notice takes effect.
 - (b) create, in respect of the municipal areas mentioned under Column "A" of Schedule 1, magisterial districts to be known by the names referred to under Column "B" of Schedule 1 and establish courts named under Column "C" of Schedule 1 for the said districts for the purpose of:
 - (i) The trial of persons accused of committing any offences in respect of which it has jurisdiction as contemplated in section 89 and 92 of the Act or any other law; and
 - (ii) Adjudication of civil disputes in respect of which it has jurisdiction as contemplated in section 29(1) of the Act or any other law.
 - (c) specify, in respect of each magisterial district named under column "B" of the attached Schedule 1, seats of the magistracy, as reflected under Column "D" of the said Schedule.

- (d) detach portions of the magisterial districts mentioned under Column "B" of the attached Schedule 1, to create sub-districts to be known by the names referred to under Column "E" and establish detached courts mentioned under Column "F" of the attached Schedule 1 for the said sub-districts.
 - (e) appoint within the districts named under Column "B" of the attached Schedule 1 and sub-districts named under Column "E" of the attached Schedule 1, places for the holding of court, as reflected under Column "G" of the said Schedule; and
 - (f) define in respect of each magisterial district and sub-district named under Columns "B" and "E" of the attached Schedule 1, respectively, local limits as described in the accompanying point-to-point descriptions, as reflected in the attached Schedule 2.
2. Any criminal or civil proceedings, which on the date on which this Notice takes effect, have already been placed on the court roll for trial or hearing, in a court whose area of jurisdiction has been altered by this Notice, and which have not been finalised, shall be dealt with and finalised by the court where the matter is enrolled, as if this Notice has not been published.
